# **Engagement Report – Seaford Wetlands Rejuvenation Project (August 2022)**

## **Project Overview**

Frankston City Council led this community engagement to inform the Seaford Wetlands Rejuvenation Project ('Project'), as part of the Victorian Government's \$154 million Suburban Parks Program. Between 21 February-31 March 2022, we consulted the community on how we can improve and enhance the Seaford Wetlands.

## Quick Engagement Stats - 21/02/22 - 31/03/22

## Frankston City Council received over 500 responses from community members:

- 80 (approx.) people provided feedback and input during the public pop-ups.
- 121 people completed the online survey. Majority of survey respondents were visitors of the Wetlands (94.17%), 41% on a weekly basis, and 31% on a daily basis.
- 267 people completed the quick poll.
- 68 people inputted into the interactive online map.
- 3 email responses were received to the consultation.
- 94 people 'followed' the project to receive ongoing updates.

Respondents: elderly people, environmental groups, families, local residents & young people.

## **Summary of feedback**

#### The feedback provided by community can be summarised as follows:

- All upgrades to the Seaford Wetlands should prioritise the area as a natural reserve, with high ecological values, and comply with the Ramsar Management Plan.
- The final design for the new pedestrian bridge should respond to the preference of 68% of responders: Option A – wooden cladded bridge.
- The most commonly requested facilities should be installed around the new bridge, including native plants, bench seat, drinking fountain, signage and lighting.
- The final location for the shared use path should respond to the preference of 81% of responders: Option A – Kananook Creek path. Residents of Palm Beach Drive should be further engaged given their concerns.
- The most commonly requested new facilities should be added to locations identified in the interactive online map. All facilities upgrades should ensure the environmental significance and natural aesthetics of the wetlands are preserved.
- A professional designed art mural should be installed at the Down's Estate Shed, as proposed by the Down's Estate Community Project.







## Outcomes

The Project Steering Group has been informed that overall, the community overwhelmingly value Seaford Wetlands for its ecological values. While upgrades to the reserve are seen as a positive step, it is important that they preserve the environmental significance and natural aesthetics of the wetlands, and that community members (particularly nearby residents) are regularly informed and engaged.

Recommendations made to the Steering Group, and endorsed, as a result of this engagement include:
